2. This commitment to Washington University will be honored by the donor as follows:



3. Washington University will utilize this gift as follows: The purpose of this expendable gift is to support Infantile Neuroaxonal Dystrophy (INAD) research. The gift will be used for this purpose under the direction of Dr. Paul T. Kotzbauer, MD, PhD, Associate Professor, Division of Adult Neurology, Department of Neurology.
4. The gift will go in the already established **Jasper Valentijn Foundation Fund (3857-30520)**.

6. For recognition purposes, the donor should be listed in honor rolls or publications as follows:






